OUR FOUNDATION THE BAKER FAMILY

For Alice Graham Baker, family was at the heart of everything in life.

Alice Graham married Captain James Addison Baker in Waco, TX on June 10, 1883, and together they had six children. Family, faith, and community were at the center of their lives. Captain and Alice were caring, hard-working, influential people who used every opportunity to make a difference in the lives of others.

Captain Baker was a lawyer who, along with his father and talented associates, built Houston's first modern law firm. He was a banker, and in 1912 orchestrated the largest bank merger up to that time. And he was the trusted attorney of millionaire William Marsh Rice. After Rice was murdered, Captain Baker worked tirelessly to protect his client's fortune and fulfill his wishes to create an institution of higher learning in Houston. Today we know it as the internationally acclaimed Rice University.

In the early 1900s, Houston experienced a period of accelerated growth. Families were moving from across the country and around the world, settling in the aging housing stock of the Second Ward.

When Alice Graham Baker learned that these families faced crowded living conditions, language barriers, and an unhealthy environment, she knew she had to act. She hosted a meeting of twelve influential, civic-minded women at her home. On February 19, 1907, they formed the Houston Settlement Association—which later became BakerRipley.

Their stated purpose was to extend “educational, industrial, social and friendly aid to all those within our reach.” Alice was named president and served in that role for eleven years.

In Alice's view, all Houstonians were her neighbors. Over the years, the Houston Settlement Association grew to include a kindergarten, cooking and sewing classes, a community center (Rusk Settlement House), English language classes, childcare for working mothers, and a substation of Houston's Carnegie Library. By 1916, Rusk Settlement House was caring for families from 23 countries through teams of volunteers under the leadership of Alice and her board.

Today, BakerRipley is one of the largest, most long-standing, and highly recognized nonprofit organizations in the country. We provide Neighbors with access to resources, education, and career opportunities that change the trajectory of their family's life. We operate Community Centers as places to gather and grow. We provide services for children, seniors, families, veterans, and immigrants. Through it all we retain the spirit of Alice Graham Baker's original mission, viewing all Houstonians as our Neighbors.

With your support, our reach continues to grow. Together the BakerRipley family—our Neighbors, staff, donors, volunteers, partners, and community members—empower and uplift, believing when individuals have what they need to thrive, opportunity abounds.

Thank you for continuing this legacy, and generously providing what Neighbors need to thrive.

ZAHIR'S STORY

Zahir and his father originally came to the United States as refugees from Afghanistan in 2016. In the years that followed, BakerRipley helped him apply for his green card, and then for U.S. Citizenship. In May 2022, Zahir successfully became a U.S. Citizen.

Zahir's father also applied for U.S. Citizenship, but had difficulty with the exam due to a mental disability. Thanks to support from BakerRipley's legal team, Zahir's father was able to get his Naturalization case approved.

Zahir works for Interfaith Ministries as a case manager serving the Dari-speaking community. **He is enrolled at Houston Community College and wants to major in political science. "I will always be grateful to BakerRipley," he says. "Their team has made a whole new life possible for me and my father."**



JESSICA'S STORY

Jessica learned about the BakerRipley FabLab from a friend, who knew of Jessica's artistic skills and aspirations to start a business. Jessica enrolled in classes and workshops at the FabLab, where she gained skills in laser cutting, 3D printing, the CNC router, and FabLab design software—then brought her visions to life.

Jessica's Art Shoppe, now on Facebook and Instagram, features a large inventory of unique earrings she designed. She took her merchandise to the Frida Love Market hosted on the Navigation Esplanade, and her pop-up shop was a huge success.

Jessica looks forward to continuing her work with the BakerRipley Small Business team so she can grow and innovate her business.



ELLA'S STORY

Ella has been an active participant in BakerRipley's Senior Health and Wellness program since October 2014. After her husband's death she sought a place for camaraderie and friendship—but what she found was a place to belong.

At her BakerRipley Senior Health and Wellness Center, Ella has created an extensive support system that keeps her encouraged and uplifted. She not only participates in the programs, but also volunteers. Ella enjoys decorating and setting up for festivities, and even obtained her food handler's certification so she can assist during mealtime.

Ella is grateful to BakerRipley and all the people who are now such an important part of her life. The Senior program, she says, "gives me a reason to keep going."

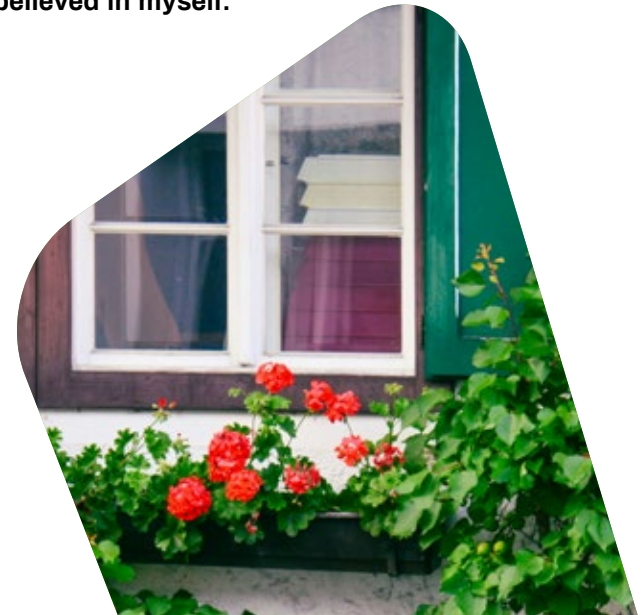


SAMANTHA'S STORY

Samantha was in an abusive marriage. She decided to leave her husband to make a better life for herself and her daughter, but finding a shelter was difficult due to COVID-19 restrictions. After about a week, they were accepted to the Bay Area Turning Point shelter.

At the shelter Samantha met Trennie, a BakerRipley Rapid Re-Housing Program Caseworker. Trennie helped Samantha enroll in the program—and move into a furnished apartment.

"Less than 30 days after walking out of my abusive situation, my daughter and I had the keys to a new home," Samantha says. "I am really blessed to have found BakerRipley and Ms. Henry. She believed in me when I wasn't sure I believed in myself."



THE BAKERRIPLEY EXPERIENCE

Last year, BakerRipley transitioned from its Heart of Gold Luncheon to the inaugural BakerRipley Experience, held October 20, 2022 and presented by Shell.
